**Project Description:** Susannah's House, Inc. will provide temporary housing and substance use disorder treatment for sixteen low-income pregnant mothers and their children at no charge. This will allow mothers to be drug-free and off the street with their children and will decrease the number of homeless pregnant and parenting mothers. It will help mothers establish financial responsibility and the achievement of job, educational and parenting goals while also gaining and maintaining healthy sobriety. Federal funding will be used for phase II construction of housing for 8 mothers and infants, with phase I housing for 8 mothers and infants slated for completion in June 2022. Susannah's House complies with Title VI, is licensed by the TN Dept. of Mental Health and Substance Abuse Services, and its housing will improve a blighted area.
